目的 Objective

隨著人均壽命延長和社會福利開支收緊,財務策劃及財富管理對香港市民的生活愈趨重要。今時今日,投資理財的天空變得愈來愈大,客戶需要的不僅是一位保險顧問,而是一位全面專業,能助客戶實現人生各階段理財需要的財務策劃師。事實上,適者生存,從業員若不盡快趕上財務策劃的列車,提升個人競爭力,實在難以在這大趨勢下生存。為此,香港人壽保險從業員協會(下稱「保協」)及香港經濟日報舉辦保協傑出財務策劃師大賽(下稱「BFPA」),以表彰一眾為客戶提供優質理財服務的同業。

With longer life expectancy and tightened government expenditure on social welfare, financial planning and wealth management are becoming more crucial to the livelihood of Hong Kong citizens. Thus, Life Underwriters Association of Hong Kong (hereinafter "LUAHK") and Hong Kong Economic Times organize the Best Financial Planner Award (hereinafter "BFPA") to honor and recognize Hong Kong's most outstanding financial planners for their professionalism and dedication in serving the needs of their clients.

參賽資格 Eligibility

每間贊助公司均可提名其符合下列要求之財務策劃顧問參賽:

Each sponsoring company may nominate their financial planners to the BFPA competition. Applicants who meet the following requirements are eligible to apply:

- 為「保協」2022年度會員 An active member of LUAHK in year 2022
- <u>為贊助公司之財務策劃顧問</u> A financial planner of the sponsoring company
- 2021年全年或於2022年6月10日或之前的一年內首年佣金達HK\$120,000或以上 First Year Commission HK\$120,000 or above in the year of 2021, or within a year on or before 10 Jun 2022

參賽要求

Requirement

 Submit 2 e-copies, (1 in PDF and 1 in Microsoft Word format) by uploading to https://www.luahk.org/upload_application.
 Total word count must be shown. * The content of the hard copies and e-files (in PDF and Word format) must be consistent.

Only financial planners of sponsoring companies are eligible to apply. No limit on the number of nomination and application. However, each company shall have at least 5 BFP Qualifiers to join. Each applicant shall submit one proposal only. **The late submission, no matter or what reason, shall not be accepted.**

初賽 First Round	參賽者必須提交一份財務計劃書[一式兩份的書面財務計劃書及電子檔(PDF檔及微軟 WORD檔各一)]。符合最基本要求之參賽者將獲「2022傑出財務策劃師入選者」名銜。每間贊助公司之第三、四及五名將獲「2022傑出財務策劃師 - 優異獎」名銜;第一、二名將進入決賽競逐「2022傑出財務策劃師 - 金獎」及「2022傑出財務策劃師 - 銀獎」名銜。贊助公司之「2022傑出財務策劃師 - 入選者」人數如不足5名,所有參賽者將被取消資格。 Applicants are required to submit their written financial proposals, in duplicate, together with the PDF file and Microsoft WORD file. For those who meet our minimum requirements will be awarded as 2022 BFP Qualifiers. Among all qualifiers of that company, the 3rd, 4th and 5th score the highest will be awarded as 2022 BFP - Merit Award. The top 2 qualifiers will enter the final round to compete for 2022 BFP - Silver Award, and 2022 BFP - Gold Award. Each company shall have at least 5 2022 BFP Qualifiers. Otherwise, all the applicants from that company will be disqualified.

Applicant who obtain the highest score among all gold awardees will be awarded as 2022 LUA BFP.

初賽:書面財務計劃書

First Round: Written Proposal

- 1. 每位多賽者只能提交一份財務計劃書[一式兩份的書面財務計劃書及電子檔(PDF檔及微軟WORD檔各一)]
 Each applicant shall submit one financial proposal only. (2 hard copies in duplicate and 2 e-copies, 1 in PDF and 1 in Microsoft Word format).
- 2. 財務計劃書必須為真實個案,並以繁體中文、簡體中文或英文撰寫。
 The financial proposal must base on the real case, written in Traditional Chinese, Simplified Chinese or English.
- 3. 填妥及簽署參賽者聲明。

Application Declaration Form must be filled in and signed.

4. 參賽者之個人資料(如:姓名,公司名稱,個人相片)必須印在單頁A4紙上,並釘製於整份財務計劃書前,以便識別身份。若不是釘製在整份財務計劃書前,一概以取消參賽資格計。此印有個人資料的單頁A4紙不等於封面,只作內部記錄,不會呈交與評審,以示公正。

Applicants should put their personal information (ie. full name, personal photo, name of the company) on a separated single sided A4 paper. It must be attached separately on the cover of the financial proposal, the applicant will be disqualified if the A4 paper is not attached on the cover of the financial proposal separately. The personal information printed on this A4 paper is not a cover. The purpose is to identify the applicant's identity for internal use. No personal information will be revealed to the judges.

5. 所有內容均不能顯示任何可識別參賽者身份相關資料、個案客戶、任何保險公司/獨立理財公司及有關產品之真實名稱,請以假名代替。一經發現,一概取消參賽資格。

The source of all citation, statistics and data must be clearly shown on the financial proposal. No relevant information that can identify the applicant, the real name of the customer, insurance company/ independent wealth management company or related products can be displayed on the financial proposal. If found, applicants will be disqualified. Please use pseudonyms as a replacement if necessary.

6. 整份參賽財務計劃書,必須清楚顯示所有引用資料及數據之出處來源。

The source of all citation, statistics and data must be clearly shown on the financial proposal.

7. 請以微軟WORD檔編寫(必須能顯示整份計劃書之總字數);建議用新細明體字型,最少12點字體,單行問距;除封面、目錄及附錄外,其他內文篇幅至少10單頁,最多20單頁(即至少4,000個中文字或1,800個英文字),並須釘裝成冊。

The financial proposal must be written in Microsoft WORD format, total word count must be shown. The financial proposal (excluding the cover page, table of contents and appendices) must be at least 10 pages, 20 pages in maximum (i.e. 4,000 Chinese characters or 1,800 English characters at least). Binding is required. It is recommended to write in Times New Roman; with at least 12 font size and single line spacing.

8. 参賽財務計劃書,只按2022年大賽規則進行評分;歷屆之大賽規則將不作參考及爭議。

All the submitted financial proposals are only assessed according to 2022 BFPA Competition rules and regulations; The assessment rules and regulations in the previous BFPA Competition will not be taken as a reference and debate.

9. 所有參賽財務計劃書之版權為「保協」所擁有。

All the submitted financial proposals shall be the property of LUAHK.

10. 參賽者必須遵守財務策劃師之專業操守,例如知識產權及客戶/公司/產品等資料保密原則等。如發現抄襲、計劃書格式不合規格、違反資料保密原則等,參賽者將被取消參賽資格。

All professional code of conduct, such as client, company, product, etc. and confidentiality and intellectual property, must be observed. With any violation in terms of plagiarism, wrong formats of proposals, disclosure of confidential information and so forth, applicants will be disqualified.

Final Round: Oral Presentation

1. 每間贊助公司首兩名入選者須於評審團面前即席演譯其財務策劃書。

Top 2 qualifiers from each sponsoring company are required to perform a live demonstration of their financial proposals in front of the panel of judges.

2. 參賽者可以廣東話、普通話或英文滙報。

Oral presentation shall be delivered Cantonese, Mandarin or English.

3. 每位參賽者有15分鐘完成口頭滙報,及約10分鐘回應評審團提問。

Each applicant shall have 15 minutes for presentation and around 10 minutes for answering questions from the panel of judges.
